PRELIMINARY DEFINITIONS AND NOMENCLATURES

Academic Council: The Academic Council is the highest academic body of the institute and is responsible for the maintenance of standards of instruction, education and examination within the institute. Academic Council is an authority as per UGC regulations and it has the right to take decisions on all academic matters including academic research.

Academic Autonomy: Means freedom to an institute in all aspects of conducting its academic programs, granted by UGC for Promoting Excellence.

Academic Year: It is the period necessary to complete an actual course of study within a year. It comprises two consecutive semesters i.e., Even and Odd semester.

AICTE: Means All India Council for Technical Education, New Delhi.

Autonomous Institute: Means an institute designated as autonomous by University Grants Commission (UGC), New Delhi in concurrence with affiliating University (Jawaharlal Nehru Technological University, Hyderabad) and State Government.

Backlog Course: A course is considered to be a backlog course if the student has obtained a failure grade (F) in that course.

Basic Sciences: The courses offered in the areas of Mathematics, Physics, Chemistry, Biology etc., are considered to be foundational in nature.

Betterment: Betterment is a way that contributes towards improvement of the students' grade in any course(s). It can be done by either (a) re-appearing or (b) re-registering for the course.

Board of Studies (BOS): BOS is an authority as defined in UGC regulations, constituted by Head of the Organization for each of the departments separately. They are responsible for curriculum design and updation in respect of all the programs offered by a department.

Certificate course: It is a course that makes a student gain hands-on experience and skill required for holistic development in a specific area/field.

Choice Based Credit System: The credit based semester system is one which provides flexibility in designing curriculum and assigning credits based on the course content and hours of teaching along with provision of choice for the student in the course selection.

Compulsory course: Course required to be undertaken for the award of the degree as per the program.

Commission: Means University Grants Commission (UGC), New Delhi.

Continuous Internal Examination: It is an examination conducted towards internal assessment.

Course: A course is a subject offered by the University for learning in a particular semester.

Course Outcomes: The essential skills that need to be acquired by every student through a course.

Credit: A credit is a UNIT that gives weight to the value, level or time requirements of an academic course. The number of 'Contact Hours' in a week of a particular course determines its credit value. One credit is equivalent to one lecture hour per week.

Credit point: It is the product of grade point and number of credits for a course.

Cumulative Grade Point Average (CGPA): It is a measure of cumulative performance of a student over all the completed semesters. The CGPA is the ratio of total credit points secured by a student in various courses in all semesters and the sum of the total credits of all courses in all the semesters. It is expressed up to two decimal places.

Curriculum: Curriculum incorporates the planned interaction of students with instructional content, materials, resources and processes for evaluating the attainment of Program Educational Objectives.

Degree with Specialization: A student who fulfills all the program requirements of her/his discipline and successfully completes a specified set of professional elective courses in a specialized area is eligible to receive a degree with specialization like Structural Engineering, Embedded Systems, CSE, etc.

Department: An academic entity that conducts relevant curricular and co-curricular activities, involving both teaching and non-teaching staff and other resources in the process of study for a degree.

Detention in a course: Student who does not obtain minimum prescribed attendance in a course shall be detained in that particular course.

Dropping from the Semester: A student who doesn't want to register for any semester can apply in writing in prescribed format before commencement of that semester.

Elective Course: A course that can be chosen from a set of courses. An elective can be Professional Elective and/or Open Elective.

Evaluation: Evaluation is the process of judging the academic performance of the student in her/his courses. It is done through a combination of continuous internal assessment and semester end examinations.

Grade: It is an index of the performance of the students in a said course. Grades are indicated by alphabets.

Grade Point: It is a numerical weight allotted to each letter grade on a 10 point scale.

Institute: Means Institute of Aeronautical Engineering, Hyderabad unless indicated otherwise by the context.

Massive Open Online Course (MOOC): MOOC courses inculcate the habit of self-learning. MOOC courses would be additional choices in all the elective group courses.

Pre-requisite: A course, the knowledge of which is required for registration into higher level course.

Core: The courses that are essential constituents of each engineering discipline are categorized as professional core courses for that discipline.

Professional Elective: A course that is discipline centric. An appropriate choice of minimum number of such electives as specified in the program will lead to a degree with specialization.

Program: Master of Technology (MTech) degree program.

Program Educational Objectives: The broad career, professional and personal goals that every student will achieve through a strategic and sequential action plan.

Project work: It is a design or research based work to be taken up by a student during his/her second year to achieve a particular aim. It is a credit based course and is to be planned carefully by the student.

Re-Appearing: A student can reappear only in the semester end examination for the theory component of a course, subject to the regulations contained herein.

Registration: Process of enrolling into a set of courses in a semester of a Program.

Regulations: The regulations, common to all M.Tech programs offered by Institute are designated as “IARE-R18” and are binding on all the stakeholders.

Semester: It is a period of study consisting of 15 to 18 weeks of academic work equivalent to normally 90 working days. The odd semester starts usually in July and even semester in December.

Semester End Examinations: It is an examination conducted for all courses offered in a semester at the end of the semester.

S/he: Means “she” and “he” both.

Student Outcomes: The essential skill sets that need to be acquired by every student during her/his program of study. These skill sets are in the areas of employability, entrepreneurial, social and behavioral.

University: Means the Jawaharlal Nehru Technological University Hyderabad, Hyderabad.

Withdraw from a Course: Withdrawing from a course means that a student can drop from a course within the first two weeks of the odd or even semester (deadlines are different for summer sessions). However s/he can choose a substitute course in place of it by exercising the option within 5 working days from the date of withdrawal.

Words ‘he’, ‘him’, ‘his’, occur, they imply ‘she’, ‘her’, ‘hers’ also.

ACADEMIC REGULATIONS (R23)

1.0	POST- GRADUATE DEGREE PROGRAMME IN MASTER OF COMPUTER APPLICATIONS
1.1	These academic rules and regulations are applicable to the students admitted from the academic year 2023-24 onwards into 2 years (4 Semesters) MCA Programs under Choice Based Credit System(CBCS) at its autonomous institution with effect from the academic year 2023-24
2.0	ELIGIBILITY FOR ADMISSION
2.1	Admission to the post graduate programme shall be made either on the basis of the merit rank obtained by the qualified student in entrance test ICET conducted by the Andhra Pradesh State Government as per the norms of Andhra Pradesh State Council of Higher Education (APSCHE)
2.2	The medium of instructions for the entire post graduate programme in management will be English only.
3.0	MCA PROGRAMME PATTERN
3.1	A student after securing admission shall pursue the post graduate programme in management in a minimum period of two academic years (4 semesters), and a maximum period of four academic years (8 semesters) starting from the date of commencement of first year first semester, failing which student shall forfeit the MCA course. Each semester is structured to around 24 credits, totaling to 96 credits for the entire MCA programme. Each student shall secure 96 credits required for the completion of the post graduate programme and award of the MCA degree.
3.2	A student eligible to appear for the end examination in a course, but absent or has failed in the end examination may appear for that course at the next supplementary examination when offered.
3.3	When a student is detained due to lack of shortage of attendance he/she may be re-admitted when the semester is offered after fulfillment of academic regulations. In such case, he/she shall be in the academic regulations into which he/she is readmitted.
3.4	UGC/ AICTE specified definitions/ descriptions are adopted appropriately for various terms and abbreviations used in these academic regulations/ norms, which are listed below.
3.5	Semester scheme Each under graduate programme is of 2 academic years (4 semesters) with the academic year being divided into two semesters of 16 weeks (around 90 instructional days) each and semester having – Continuous Internal Evaluation (CIE) and Semester End Examination (SEE). Choice based Credit System (CBCS) and Credit Based Semester System (CBSS) as indicated by UGC and curriculum / course structure as suggested by AICTE are followed.
3.6	Credit courses All subjects/ courses are to be registered by the student in a semester to earn credits which shall be assigned to each subject/ course in an L: T: P: C (Lecture : Tutorial : Practical : Credits) structure based on the following general pattern.

	<ul style="list-style-type: none"> • One credit for one hour/ week/ semester for theory/ lecture (L) courses. • One credit for two hours/ week/ semester for laboratory/ practical (P) courses or Tutorials (T).
3.7	Subject Course Classification All subjects/ courses offered for the post graduate programme in management (MBA. degree programmes) are broadly classified as follows. The ASCET has followed almost all the guidelines issued by AICTE/UGC.
4.0	ATTENDANCE REQUIREMENTS:
4.1	A student shall be eligible to appear for the semester end examinations, if student acquires a Minimum of 75% of attendance in aggregate of all the subjects/ courses for that semester.
4.2	Shortage of attendance in aggregate up to 10% (65% and above, and below 75%) in each semester may be condoned by the college academic committee on genuine and valid grounds, Based on the student's representation with supporting evidence.
4.3	A stipulated fee shall be payable towards condonation for shortage of attendance to the Institute as decided by the College Academic Committee.
4.4	Shortage of attendance below 65% in aggregate shall in no case be condoned.
4.5	Students whose shortage of attendance is not condoned in any semester are not eligible to take their end examinations of that semester. They get detained and their registration for that semester shall stand cancelled. They will not be promoted to the next semester. They may seek re-registration for all those subjects registered in that semester in which student was detained, by seeking re-admission into that semester as and when offered; in case if there are any professional electives and/ or open electives, the same may also be re-registered if offered. However, if those electives are not offered in later semesters, then alternate electives May be chosen from the same set of elective subjects offered under that category.
4.6	A student fulfilling the attendance requirement in the present semester shall not be eligible for Readmission into the same class.
5.0	ACADEMIC REQUIREMENTS The following academic requirements have to be satisfied, in addition to the attendance requirements mentioned in item no.4.
5.1	A student shall be deemed to have satisfied the minimum academic requirements and earned the credits allotted to each theory, practical, design subject or project if he secures not less than 40% of marks (i.e., 24) in the end semester examination and a minimum of 50% of marks (i.e., 50) in the sum total of the internal evaluation and end examination taken together.
5.6	A student shall register and put up minimum attendance in all 96 credits and earn all the 96 credits. Marks obtained in all 96 credits shall be considered for the calculation of aggregate percentage of marks obtained
5.7	Students who fail to earn 96 credits as indicated in the course structure within eight academic years from the year of their admission shall forfeit their seat in MCA Course and their admission shall stand cancelled
6.0	DISTRIBUTION AND WEIGHTAGE OF MARKS
6.1	The performance of a student in each semester shall be evaluated through internal evaluation and /or an external evaluation conducted semester wise.
6.2	The performance of a student in every theory course shall be evaluated for total of 100 marks each, of which the relative weightage for Continuous Internal Assessment and Semester End Examination shall be 40 marks and 60 marks respectively.

6.3	<p>The performance of a student in every practical course shall be evaluated for total of 100 marks each, of which the relative weightage for Continuous Internal Assessment and Semester End Examination shall be 40 marks and 60 marks respectively.</p>
6.4	<p>Internal Evaluation for Theory Course:</p> <p>The total internal weightage for theory courses is 40 marks with the following distribution.</p> <ul style="list-style-type: none"> ➤ 30 marks for Mid-Term Examination ➤ 10 marks for Assignment Test <p>While the first mid-term examination shall be conducted on the 50% of the syllabus (Unit-I, Unit-II, & 50% of Unit-III), the second mid-term examination shall be conducted on the remaining 50% of the syllabus (50 % of Unit III, Unit-IV & Unit-V).</p> <p>10 marks are allocated for assignment test (as specified by the subject teacher concerned). The first assignment should be conducted after completion of Unit-I for 10 marks and the second assignment should be conducted after completion of Unit-IV for 10 marks. The final Assignment Test marks will be the average of these two.</p> <p>Two midterm examinations each for 30 marks with the duration of 90 minutes each will be conducted for every theory course in a semester. The midterm examination marks shall be awarded giving a weightage of 80% in the midterm examination in which the student scores better performance and 20% in the remaining midterm examination.</p> <p>The final mid-term marks obtain by the addition of these two (80% + 20%).</p> <p>Example: If a student scores 33 marks and 34 marks in the first and second mid-term examinations respectively, then Weighted Average Marks = $34 \times 0.8 + 33 \times 0.2 = 33.8$, rounded to 34 Marks.</p> <p>Note: The marks of any fraction shall be rounded off to the next higher mark.</p>
6.5	<p>Pattern of the midterm examination question paper is as follows:</p> <ul style="list-style-type: none"> ➤ A total of three questions ➤ Question paper contains six questions are to be designed taking three questions from each unit (Unit Wise - Either or type) of the three units. (3X10=30 Marks) <p>Pattern of the Assignment Test is as follows:</p> <ul style="list-style-type: none"> ➤ Five assignment questions are given in advance, out of which two questions given by the concerned teacher has to be answered during the assignment test ➤ Sum of Assignment Tests marks is considered. <p>Note: A student who is absent for any Mid-Term Examination/ Assignment Test, for any reason whatsoever, shall be deemed to have scored zero marks in that Mid-Term Examination/ Assignment Test and no make-up test shall be conducted.</p>
6.6	<p>Internal Evaluation for Practical Course:</p> <p>For practical subjects there shall be a Continuous Internal Assessment during the semester for 40 internal marks. Out of the 40 marks for internal evaluation, day-to-day assessment in the laboratory shall be evaluated for 15 marks and internal practical examination shall be evaluated for 25 marks conducted by the laboratory teacher concerned.</p>
6.7	<p>Project Work:</p> <p>Out of a total of 200 marks for the project work, 60 marks shall be for Internal Evaluation and 140 marks for the End Semester Examination. The End Semester Examination (viva-voce) shall be conducted by an External examiner nominated by the Principal, HOD & Supervisor as a committee. The Internal Evaluation shall be made by the departmental committee, on the Basis of two seminars given by each student on the topic of his project. For Internal Evaluation Concern The candidate has to publish a paper in any reputed journal which carries 10 marks out of 60 marks.</p>

6.8	<p>External Evaluation for Theory Course - Semester End Examination: The Semester End Examination in each theory subject shall be conducted for 3 hours duration at the end of the semester for 60 marks.</p> <p>Pattern of the Semester End Examination question paper is as follows:</p> <ul style="list-style-type: none"> ➤ Question Paper contains ten questions are to be designed taking two questions from each unit (Unit Wise - Either or type) of the total five units. (5X12=60 Marks) <p>A student has to secure not less than a minimum of 40% of marks (24 marks) exclusively at the Semester End Examinations in each of the theory subjects in which the candidate had appeared. However, the candidate shall have to secure a minimum of 50% of marks (50 marks) in both external and internal components put together to become eligible for passing in the subject.</p>
6.11	<p>External Evaluation for Practical Course</p> <p>Out of 60 marks 40 marks are allocated for experiment (procedure for conducting the experiment carries 20 marks & execution and result-20) and 15 marks for viva- voce examination with 5 marks for the record.</p> <p>Each Semester External Lab Examination shall be evaluated by an Internal Examiner along with an External Examiner appointed by the Principal.</p> <p>A candidate shall be declared to have passed in individual lab course if he secures a minimum of 50% aggregate marks (50 marks) (Internal & Semester External Examination marks put together), subject to a minimum of 50% marks (30 marks) in the semester external examination.</p>
6.12	<p>Internal Evaluation for Project Work:</p> <p>The object of Project work is to enable the student to extend further the investigative study taken up as the project under the guidance of the supervisor/ guide from the department.</p> <p>The assignment normally includes:</p> <ul style="list-style-type: none"> • Preparing an action plan for conducting the investigation including the team work. • In depth study of the topic assigned. • Review and finalization of the approach to the problem relating to the assigned topic. • Final development of product/process, testing, results, conclusions and further direction. • Preparing a paper for conference presentation/ publication in journal if possible. • Preparing a dissertation in the standard format for being evaluated by the department. • Final presentation of the work done before the Project Review Committee (PRC). <p>Project Work is allocated 60 internal marks. Out of 60, 30 marks are allocated for the supervisor/guide and head of the department to be evaluated based on two seminars given by each student on the topic of the project. The other 30 marks shall be evaluated on the basis of his presentation on the work done on his project by the Departmental Committee comprising of Head of the Department, respective supervisor/ guide and two senior faculty of the department appointed by the Principal.</p>
6.13	<p>External Evaluation for Project Work:</p> <p>The Semester End Examination for project work done during IV Semester for 140 marks shall be conducted by a Project Review Committee (PRC).</p> <p>A candidate shall be declared to have passed in project work if he secures a minimum of 50% aggregate marks (100 marks) (Internal & Semester External Examination marks put together), subject to a minimum of 50% marks (70 marks) in the project work end examination. The External examiner is appointed by the Principal.</p> <p>Every candidate shall be required to submit thesis or dissertation after taking up a topic</p>

	<p>approved by the college/ institute.</p> <ul style="list-style-type: none"> ➤ Registration of Project work: A candidate is permitted to register for the project work after satisfying the attendance requirement of all the courses (theory and practical courses of I , II and III Sem) ➤ An Internal Departmental Committee (I.D.C) consisting of HOD, Supervisor and one internal senior expert shall monitor the progress of the project work. ➤ The candidate can submit Project thesis with the approval of I.D.C. at the end of the IV semester Instruction as per the schedule. Extension of time within the total permissible limit for completing the programme is to be obtained from the Head of the Institution. ➤ The student must submit status report at least in two different phases during the project work period. These reports must be approved by the I.D.C before submission of the Project Report. ➤ The viva-voce examination may be conducted for all the candidates as per the IV semester examination schedule. ➤ Three copies of the Thesis / Dissertation certified in the prescribed form by the supervisor & HoD shall be presented to the HoD. ➤ The HoD shall submit a panel of three experts for a maximum of every 5 students. However, the viva voce examiners will be nominated by the Principal. 																								
6.14	<p>Re-Registration For Improvement of Internal Evaluation Marks:</p> <p>Following are the conditions to avail the benefit of improvement of internal evaluation marks.</p> <ul style="list-style-type: none"> ❖ The candidate should have completed the course work and obtained examinations results for I, II, III & IV semesters. ❖ He should have passed all the subjects for which the internal evaluation marks secured are more than 50%. ❖ Out of the subjects the candidate has failed in the examination due to Internal evaluation marks secured being less than 50%, the candidate shall be given one more chance for each Theory subject and for a maximum of three Theory subjects for Improvement of Internal evaluation marks. 																								
	<ul style="list-style-type: none"> ❖ The candidate has to re-register for the subjects so chosen and fulfill all the academic requirements. ❖ For each subject, the candidate has to pay a fee equivalent to one third of the semester tuition fee and the amount is to be remitted in the form of D.D. in favour of 'The Principal, Audisankara College of Engineering & Technology' payable at Gudur along with the requisition through the Controller of the Examinations of the college. ❖ In the event of availing the Improvement of Internal evaluation marks, the internal evaluation marks as well as the End Examinations marks secured in the previous attempt(s) for the reregistered subjects stand cancelled.
